Punjab Aab-e-Pak Authority (PAPA) (hereinafter referred to as the "client"), invites E-Bids from Contractors / Firms / Manufacturer / Authorized dealers having valid License from PEC in category C6 & Above with relevant code ME – 06, registered with FBR & PRA (NTN and PNTN) for E-Procurement on "e-Pak Acquisition and Disposal system (e-PADS)". 2. All E-bids must be accompanied by a Bid-Security as mentioned above in the shape of CDR / Bank Guarantee from any Scheduled Bank in Pakistan in favor of Director (Procurement & Contracts), PAPA. Late E-bids shall be rejected.

3. Original Bid Security instrument (2% of the estimated cost), as mentioned above, must be submitted in an envelope clearly marked with the Tender Serial Number and Title, before the E-bid Submission deadline at the Office of Director (Procurement & Contracts) situated at 4th Floor, EFU House, Main Gulberg, Jail Road, Lahore.

4. The complete E-bids must be submitted online on e-Procurement System (EPADS) website i.e. <https://punjab.eprocure.gov.pk> as per the following schedule:

5. **Single stage two envelopes** bidding procedure will be adopted.

6. The procuring Authority may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Punjab PP Rules 2014 (Rule-35).

7. Conditional tender will not be accepted.

8. Tendered rates and amount should be filled in figures as well as in words.

9. In case the total tendered amount is equal to or less than 5% of the approved estimated (DNIT) amount, the lowest bidder will have to deposit quality assurance security equal to the amount difference between approved DNIT amount and the quoted bid amount from the Scheduled Bank within 15 days of issuance of notice or with in expiry period of bid, whichever is earlier.

10. In case, the last date of bid submission falls in / within the official holiday(s), the last date for submission of the bids shall be the next working day.

11. The bids will be valid for 120 days.

12. Bidders are advised to ensure uploading the Bids on E-PADS Portal, well before the submission deadline, and not wait for the last date and time to upload the bid. Bid submission on E-PADS Portal shall entirely be the responsibility of the bidder. Punjab Aab-e-Pak Authority shall not be held responsible for any issue thereof.
